THIS PROPERTY IS: ACCEPTABLE WITH THE FOLLOWING REQUIREMENTS:

1. Install a septic tank, equipped with a gas tight riser, sized according to the number of bedrooms in the home.
2. Install a pump chamber equipped with a pump capable of pumping one-quarter of the daily design load at the calculated dynamic head. Install an audible and visible alarm for the pump.
2. Install 300 square feet of basal area of elevated sand mound per bedroom. System design to be finalized at on-site consultation prior to construction permit issuance.
3. System area must be located no closer than 50 feet to any private water supply.
4. System area must be laid out and approved by this department prior to construction permit issuance.
5. The system area must be located at soil boring one, located 160 feet North of 500 N. and 95 feet East of West lot line.
6. System area must be protected from excavation, grading, filling, compaction, or any other construction related activities that could render the site unsuitable if disturbed. This department recommends that a barrier be placed around the system area to protect it.
7. Requirements may change if an acceptable outlet for a perimeter drain can be found within the lot line that will allow for subsurface absorption trenches.

THIS PROPERTY IS: ACCEPTABLE WITH THE FOLLOWING REQUIREMENTS:

1. Install a septic tank, equipped with a gas tight riser, sized according to the number of bedrooms in the home.
2. Install 600 square feet of subsurface absorption field per bedroom in trenches not to exceed 16 inches in depth. Apply a minimum of 12 inches of soil over the aggregate, graded in a manner that promotes surface water runoff.
3. Install a perimeter drain along the upslope sides of the system area at 40 inches in depth, located no closer than 10 feet to any part of the system area.
4. System area must be located no closer than 50 feet to any private water supply.
5. System area must be laid out and approved by this department prior to construction permit issuance.
6. The system area must be located at soil boring two, located 310 feet North of 500 N. and 95 feet East of West lot line.
7. System area must be protected from excavation, grading, filling, compaction, or any other construction related activities that could render the site unsuitable if disturbed. This department recommends that a barrier be placed around the system area to protect it.

NOTE: A three bedroom or larger home will require the system to be pump assisted distribution.

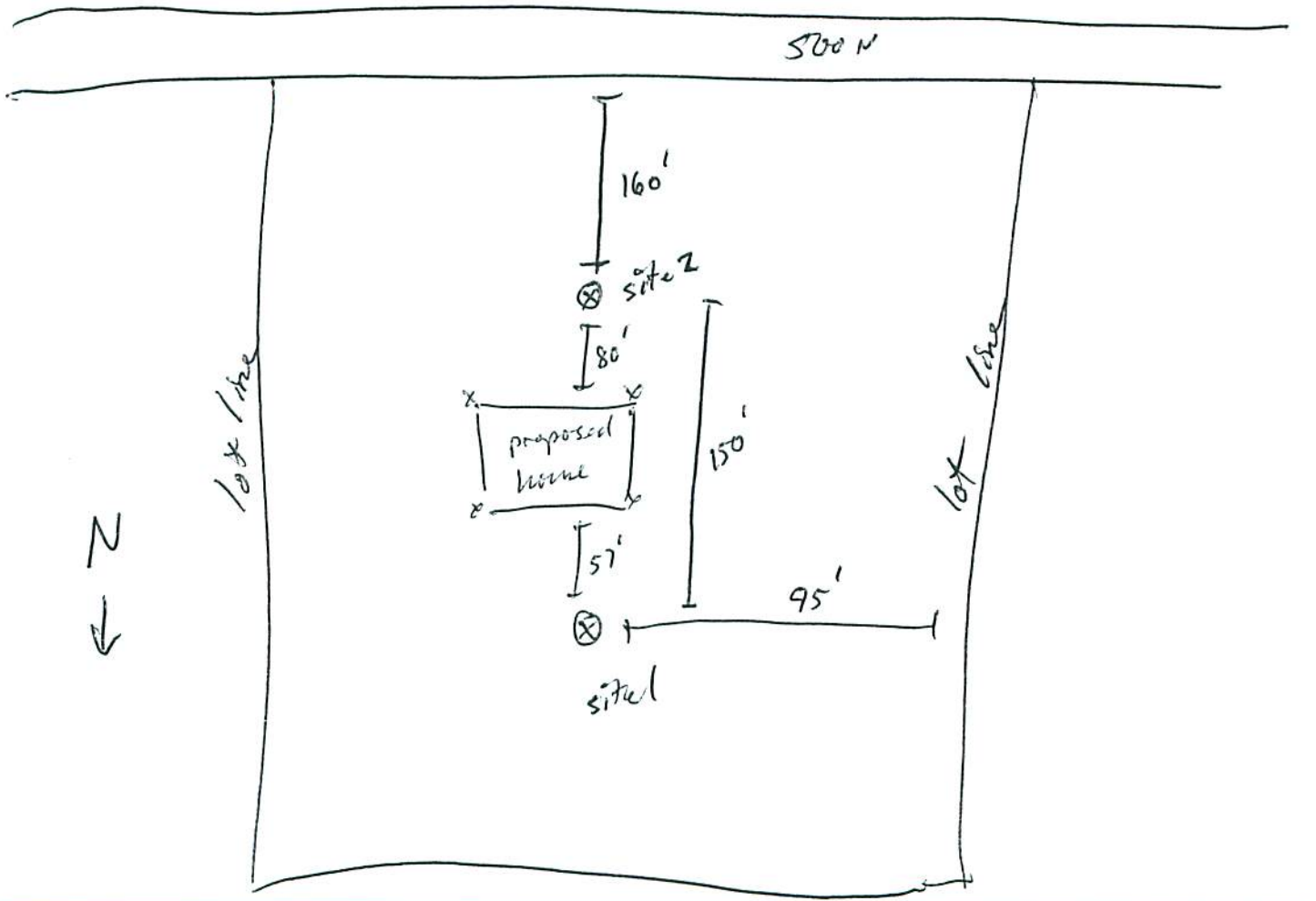
